### **NOTIFICATION**

Subject: Rescheduling of Physical Document Verification and Submission of Required Documents for Admission to Undergraduate Programmes in the Academic Year 2025–26

It is hereby notified for general information that the previously declared date of 14th August 2025 for physical verification of original documents, which was applicable to candidates provisionally selected under the First Merit List published on 29th July 2025, now stands cancelled in view of unavoidable administrative exigencies. The earlier schedule is thus rendered null and void with immediate effect.

It is further notified for the information and compliance of all concerned that the physical verification of original documents shall now be conducted on **25th August 2025 (Monday)** and **26th August 2025 (Tuesday)**, at the respective departments, for all candidates who have paid the prescribed online admission fees under any of the merit lists issued by the University for the Academic Year 2025–26. This revised schedule shall apply uniformly to the following Undergraduate programmes:

- 1. 5-Year Integrated M.Sc., in Mathematics
- 2. B.Sc. (Hons.) in Agriculture
- 3. B.Sc. (Hons.) in Forestry
- 4. B. Tech. in Dairy Technology

All such candidates are mandatorily required to report in person to their respective departments on the aforesaid revised dates for the purpose of physical verification of their original documents. The candidates shall also be required to submit self-attested photocopies of the same, in accordance with the University's admission guidelines.

Non-compliance with the requirement to appear for verification or failure to produce the required documentation within the stipulated time frame shall result in forfeiture of the provisional admission, without any further notice or opportunity for appeal.

The list of documents required to be produced at the time of verification is appended below. All candidates are advised to adhere strictly to the submission timelines specified for each document.
