**Sub: Sanction of lease of government land measuring Ac.430.37 free of annual ground rent, arrear ground rent, interest on arrear ground rent, cess, arrear cess, interest on arrear cess and incidental charges in village-Chikapar and Chakarliput under Semiliguda Tahasil of Koraput district in favour of Central University of Odisha, Koraput**

Sir,

I am directed to say that this Department, in its G.O under reference, has communicated the approval of Government for sanction of lease of Ac.430.37 of government land free of premium but subject to payment of annual ground rent, arrear ground rent, interest on arrear ground rent, cess, arrear cess, interest on arrear cess and incidental charges as calculated in the said G.O in Mouza-Chikapar and Chakarliput under Semiliguda Tahasil of Koraput district in favour of Vice Chancellor, Central University of Odisha for establishment of the Central University at Koraput.

2. Subsequently, the Secretary, Government of India, Ministry of Human Resource Development, Department of Higher Education as well as the Vice-Chancellor, Central University of Odisha, Koraput have requested the State Government to waive out all the dues and sanction lease of the land on free of cost basis.


3. The State Government, after careful consideration of the aforesaid requests and keeping in view the role the Central University plays in redressing the regional imbalance in matters of higher education by establishing such a University in Koraput district which has very low access to higher educational facilities, have been pleased to sanction lease of the aforesaid land free of all charges i.e. free of premium, annual ground rent, cess, and incidental charges in favour of Vice-Chancellor, Central University of Odisha, Koraput. The arrear ground rent, interest on arrear ground rent, arrear cess and interest on arrear cess in respect of the said

○ land which was due from the date 14.11.2009 i.e. the date from which the advance possession of the land was handed over to the University authorities, shall also be exempted.

4. This Department G.O No. 27669/ R&DM dated 18.09.2014 is modified to the above extent.

5. The other terms and conditions stipulated in the aforesaid G.O shall remain unaltered.
