The Central University of Odisha has completed various rounds of admissions for its UG/ PG Programmes. After these rounds of admissions, few seats are still vacant in various programmes. The applicants are requested to go through the list of respective programme(s) and complete the required formalities following the due procedure within stipulated time. The inclusion of name with this list shall not confer any right to be admitted; the admission will be made on the basis of academic merit index in accordance with the category-wise number of seats available in particular programme on the day of admissions. There is no guarantee of admission because a pool of applicants is included in the list/ invited for counselling. The applicants offered admission in this round of admissions are required to deposit requisite fee in online mode on same day (once the admission is offered); if an applicant is offered admission and he/she does not deposit the prescribed fees by the prescribed date/time, the offer made shall be treated as cancelled. No correspondence or appeal in this regard will be entertained. All interested applicants are hereby informed to bring **all the original and self-attested copies (1 set)** of the documents during physical documents verification. The documents must be arranged in chronological order. The details of required documents are given as **Annexure-A**.

The candidates' admission is strictly provisional. The mere fact that the name of any applicant is included in the list/merit does not imply that his/ her candidature has been finally cleared by the CUO, Odisha. If any of these shortcomings is / are detected even after admission, his /her admission is liable to be cancelled. Decisions of CUO, Odisha in all matters regarding eligibility and admission would be final and binding on all candidates. No representation or correspondence will be entertained by the CUO, Odisha in this regard. The candidature of the candidates shall be provisional and will be subject to verification of eligibility conditions with reference to original documents. Shortlisting and admission will be based on the details provided by the candidate. Hence it is necessary that applicants should have furnished accurate, full and correct information in the online application. In the event of the candidate furnishing wrong or false information, his/ her candidature may be rejected at any stage of the admission process. Requests for change of mailing address, category etc as declared in the online application, will not be entertained.
