The Payment of **Online Counseling cum Admission Fee 2020-21** has to be made through SBI Collect.

Follow the Instructions given below for making your payments.


- ▶ Corporate Customer: Firm/Company/Institution (PCK) collecting payment from their beneficiaries.


- Select State as '**Odisha**'

Enter Name of Student, Hall Ticket No, Gender, Category, Mobile No., Name of the Department, Name of the Programme and in the bottom portion of the page Enter Name, Date of Birth, mobile number & email ID for reprinting receipt.

For payment of Fee:

- Online Counseling Fee : Rs.100 (Fixed)
- Admission cum Registration Fee: you can select as per your prescribed rate of fee, if student is under OH/VI/VH category than select amount “0”
- Fee for (OH/VI) students : Only OH/VI student can select as per your prescribed rate of fee, other candidates should select amount “0”
- Fee for (VH) students : Only VH student can select as per your prescribed rate of fee, other candidates should select amount “0”

- Proceed as instructed and Click on '**Submit**'
- On the next screen, verify the details and click on 'Confirm'. If there is any correction go back and do the correction.
- Now you will be taken to payment gateway

Next screen will be the preview showing payment details.




If all the details are correct press Confirm and proceed further. If there are any corrections to be made press cancel.

You will be taken to first screen and enter the details again.
