Important Instruction to Candidates:

- The student who appeared in the CUET (UG) 2024 with the respective subject paper pattern as notified on the website are eligible for Counselling cum Registration process.
- ➤ Candidate must fulfil the minimum eligibility criteria for admission to the programme. Please note that it is the sole responsibility of the candidate to ensure eligibility at the admission stage. The admission of a candidate shall be cancelled if the eligibility claimed by the candidate is found to be incorrect during or after the admission process.
- > The candidate must refer to the list of Programmes, Programmes specific Eligibility Criteria, Fee Structure and other relevant information published on the University website.
- The candidates called for open counselling have to appear in person for physical document verification as per schedule mentioned above. On the basis of reported candidates, the concerned department will prepare the merit list as per the norms of CUO. It is also advised to report positively to the concerned Head/In-Charge of Department on scheduled date & timing with all documents (Please refer the list of documents required), failing which candidature will be cancelled.
- Online Registration for admission/counselling shall not guarantee provisional admission in a programme. Provisional admission will be offered only on the basis of position in the merit list. Fulfilment of eligibility criteria and verification of document made by the university.
- ➤ The selected candidates in the merit list can secure their admission to the UG programmes of their choice by depositing the programme fees within stipulated time. If a candidate fails to pay the fee within the stipulated time limit, the seat will be offered to the next candidate on the merit list.
