#### Admission under Kashmiri Migrant Quota

As per the MoE Instructions and UGC letter **Vide D.O. No. F.1-13/2010 CPP-II dated 23<sup>rd</sup>March, 2015**, the following concessions will be provided to the Kashmiri migrant students:

- 1. Relaxation in cut-off percentage up to 10% subject to minimum eligibility requirements.
- 2. Increase in intake capacity up to 5% programme-wise.
- 3. Reservation of at least one seat in the merit quota in technical/professional Institutions.
- 4. Waiving of domicile requirements.

Reservation of seats (except for B.Ed. programme) for Kashmiri Migrant would be supernumerary seats over and above the approved intake in each programme.
