It is hereby notified for the information of all prospective applicants that candidates seeking admission to various UG/PG programmes at the Central University of Odisha under the SC/ST/OBC (Non-Creamy Layer)/Economically Weaker Section (EWS) categories are required to submit a valid caste/category certificate issued by the competent authority in the Government of India prescribed format (Annexure – I: Format for OBC (Non-Creamy Layer) Certificate and Annexure – II: Format for EWS Certificate)

The certificate for **OBC** (**NCL**) and **EWS** categories must be issued **on or after April 01, 2025**. Certificates issued prior to this date shall **not be accepted under any circumstances**.

All category certificates must be submitted at the time of counseling/admission, and strictly within the stipulated timeline as mentioned in the admission schedule. Failure to submit a valid certificate in the required format and within the prescribed time frame will lead to forfeiture of the reservation benefit and the candidate's application shall be considered under the General Category. Furthermore, no request for extension of time to submit the caste/category certificate shall be entertained under any circumstances.

Applicants are strongly advised to ensure compliance with the above requirements and obtain the necessary documents well in advance to avoid any inconvenience or disqualification during the admission process.
