### Important Instructions:

IN ABSENCE OF ORIGINAL PHOTO ID PROOF, **CANDIDATES WILL NOT BE ALLOWED TO ENTER IN THE TEST CENTRE PREMISES.** E-Aadhar card is not valid for Photo ID proof for verification purpose in the examination.
- Candidate must bring his/her recent passport size photograph to be pasted on the attendance sheet.**
- Carry a black/blue ball pen to fill the OMR sheet.
- MOBILE PHONES/ PAGERS/ CALCULATORS/ SCANNING DEVICES/ ANY OTHER ELECTRONIC GADGET/ SCALES/ ALGORITHM TABLES are strictly prohibited inside the test centre. Test centre will not be responsible for its safety/loss.
- The candidates will not be permitted to leave the examination hall till the end of the examination in a given session.
- Wearing a mask/face cover is mandatory for all candidates. Candidates without mask/face cover will not be allowed into the examination centre.
- If a candidate has any symptom of COVID-19, he/she should inform the examination centre in-charge.
