Provided the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/ Bye-laws/ Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET for recruitment and appointment of Assistant Professor or equivalent positions in

- 2. Master's Degree (M.Tech.) in Dairy Engineering/Post Harvest Technology/Food Technology/Food Process Engineering with at least 55% marks or its equivalent grade in the point scale.
- 3. National Eligibility Test (NET) qualified*[conducted by the CSIR or ICAR or UGC [or] similar test accredited by the UGC like the State Level Eligibility Test (SLET/SET) or who have been awarded a Ph.D. Degree in accordance with the University Grants Commission(Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009 or 2016 or 2022 and their amendments from time to time as the case may be exempted from NET. Other Terms and conditions:

- 1. Selected candidates shall be paid an honorarium of ₹ 1500/- per lecture subject to maximum of ₹ 50,000/- per month.
- 2. The selected candidates shall be engaged on purely temporary basis for a period of one semester, likely to be extended for another semester on satisfactory performance. However, the engagement will be terminated on the joining of a regular faculty in between. The services of Guest Faculty will be terminated without notice if found unsatisfactory. **Under any circumstances, candidate cannot claim any right for permanent position.**
- 3. No TA/DA will be paid for attending the walk-in interview.
- 4. Incomplete applications will be rejected.
- 5. Before turning up for interview, please visit the University website for updates.
- 6. The Guest Faculty shall not be given the benefit of allowances, pension, gratuity and leave etc. as admissible to the regular teachers.
