**WALK IN INTERVIEW FOR ENGAGEMENT OF GUEST FACULTY**

In partial modification of Advt. No. CUO/Admn/EGF/116 dated 25.03.2025 regarding walk-in interview for engagement of Guest Faculty in the Dept. of Computer Science, it is notified for the information of all concerned that the 'Guest Faculty Essential Qualification for Computer Science' as mentioned in the above said notification may be read as:

**Guest Faculty Essential Qualification for Computer Science:**

**A.**

- i. Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned relevant allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- ii. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or who have been awarded a Ph. D. Degree accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil. Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET.

*Provided* the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/ Bye-laws/ Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET for recruitment and appointment of Assistant Professor or equivalent positions Universities Colleges Institutions subject to the fulfilment of the following conditions -

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners,
- c) An open Ph.D. viva voce of the candidate has been conducted:
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal,
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.
