

The Ph. D. in English Language and Literature is a six-semester programme. The course work is a one semester course of six months duration. It comprises FOUR papers. The first three papers are core courses, and the fourth paper can be chosen from the four Electives prescribed in the syllabus. After the completion of the first semester course-work, each student is required to choose his/her dissertation topic in consultation with the faculty members/Supervisor.

PAPER-I

- **Unit III**: Research Design: Meaning Need, Features of Good Design, concepts, Types, Basic principles of experimental design, various methods of research survey, philosophical, historical, experimental, causal comparative, Genetic, Case studies.
- **Unit IV:** Qualitative research, Quantities research, concept of measurement, causality, generalization, replication, merging the two approaches.
- **Unit V:** Tools for data collection: collection of primary data, collection of data through questionnaires, interview methods, collection of secondary data, focus group discussion, techniques of developing research tools, reliability and validity of research tools., library sources, e-sources, survey and questionnaires, books, journals, encyclopedias, bibliographies etc., Primary & secondary sources, Authenticity of sources
- **N.B.** The candidate is required to prepare a research paper of approximately 1500 words following the rules of documentation. It will be included as a part of the answer script during the Final examination.
