Instruction to Candidates:

- The candidate who appeared in the Entrance Examination 2024 for admission in M.Sc. in Botany/Zoology held on 01.09.2024 are eligible for Counselling process.
- Candidate must fulfil the minimum eligibility criteria for admission to the programme. Please note that it is the sole responsibility of the candidate to ensure eligibility at the admission stage. The admission of a candidate shall be cancelled if the eligibility claimed by the candidate is found to be incorrect during or after the admission process.
- > The candidate must refer to the Eligibility Criteria, Fee Structure and other relevant information published on the University website.
- The candidates called for open counselling have to appear in person for physical document verification as per schedule mentioned above. On the basis of reported candidates, the concerned department will prepare the merit list as per the norms of CUO. It is also advised to report positively to the concerned Admission In charge on scheduled date & timing with all documents (Please refer the list of documents required), failing which candidature shall be cancelled.
- Provisional admission shall be offered only on the basis of position in the merit list. Fulfilment of eligibility criteria and verification of document made by the university.
- The selected candidates in the merit list can secure their admission to the programmes of their choice by depositing the programme fees within stipulated time. If a candidate fails to pay the fee within the stipulated time limit, the seat will be offered to the next candidate on the merit list.

- 5. The candidates who fail to produce his/her documents/ category certificate etc. or failed to deposit the fee in the prescribed period, the allotted seat will be returned automatically. No separate notice will be given for cancellation.
- 6. Next additional merit lists may be displayed against the vacant seats, if any in Central University Odisha website. The candidates are advised to visit CUO website regularly for information/ updates.
- 7. In all case of disputes and unforeseen/contingency circumstances, the decision of the University will be final. Any form of canvassing/malpractice will lead to disqualification/cancellation of candidature.
