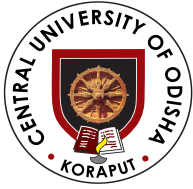

***No. of Vacancy Seat: UR = 00, OBC = 02, EWS = 00, SC = 00, ST = 00**

***A candidate belonging to a reserved category (SC/ST/OBC-NCL/EWS) is eligible to appear in both the Unreserved (UR) merit list and their respective reserved category list. If the candidate is not admitted under a UR seat but secures admission under their reserved category in any round, they may still be upgraded to a UR seat in a subsequent round, provided their merit is high enough. Under all circumstances, the UR cut-off must always be equal to or higher than the cut-off for any reserved category, ensuring the integrity of the merit system. As a result, while preparing subsequent merit lists, the number of vacancies in the UR category may decrease due to the up-gradation of high-merit reserved category candidates, and the corresponding number of vacancies in the reserved categories may increase. If the list of eligible candidates in the OBC-NCL or EWS category is exhausted, any vacant seats in such categories shall be converted to Unreserved (UR) category seats. In the event of exhaustion of eligible candidates in either SC or ST categories, vacant seats may be filled by mutual interchange between SC and ST categories, subject to applicable regulations.**

Important Information and Instructions to the Candidates:

1. All admissions are strictly provisional and subject to the fulfilment of eligibility criteria and subsequent verification of original documents. At any stage, if any certificate/document/declaration submitted by the candidate is found to be false, fabricated, or misleading, the admission shall stand cancelled with immediate effect. The University reserves the right to withdraw the offer of admission in case of any inadvertent error or oversight.
2. The Central University of Odisha shall verify the authenticity of mark sheets, certificates, and other required documents from the respective issuing authorities/institutions. If any document is found to be invalid or forged, appropriate legal action shall be initiated against the concerned candidate(s) as per the law.
3. Candidates are solely responsible for ensuring the correctness and validity of their credentials prior to reporting. Admission is subject to the production and successful verification of all original documents.
4. The admission fee must be paid online within the stipulated time in each round of admission prior to physical verification. Payment is to be made through SAMARTH portal (<https://cuocuet.samarth.edu.in/index.php/site/login>) only.
5. Candidates must appear in person with original documents as per the schedule to be notified by the University. Failure to be physically present for verification shall lead to automatic cancellation of admission without any further notice.
6. All shortlisted/admitted candidates shall mandatorily submit the **final mark sheet or certificate** of their qualifying examination **within thirty (30) days** from the date of admission. **Failure to submit** the requisite document(s) within the prescribed timeframe shall result in **automatic cancellation of admission without any prior notice**, and the University shall not entertain any request for extension or reconsideration under any circumstances. Furthermore, in cases where the submitted final mark sheet reveals that the candidate **has not secured the minimum percentage of marks or grade** required for eligibility to the respective programme as prescribed by the University, such admission shall stand **automatically cancelled**, irrespective of the stage of

- admission or attendance. The University reserves the right to withdraw such admissions forthwith and offer the seat to the next eligible candidate as per merit.
7. If a candidate fails to submit the required documents or category certificate (if applicable), or fails to pay the admission fee within the prescribed timeline, the allotted seat will be automatically forfeited without any further notice. Such seats shall be made available for the next round of admission.
 8. In case of vacancy, further merit lists may be displayed on the official website of the Central University of Odisha. Candidates are advised to regularly visit the University website for updates and instructions.
 9. The University reserves the right to subject any admitted candidate to a **medical fitness examination** conducted by the **University Medical Officer or a designated medical authority**. Admission shall be confirmed only upon certification of medical fitness by such authority.
 10. Candidates whose **qualifying examination is not recognized** by UGC, or any other statutory authority shall be deemed **ineligible for admission**, and their application or admission shall be cancelled forthwith, irrespective of the stage at which the discrepancy is discovered.
 11. Candidates who are in service and are selected for admission to any **full-time programme** must submit a **relieving order or sanctioned leave certificate** from their employer at the time of physical document verification. Failure to produce such a document shall result in **automatic withdrawal of the admission offer**.
 12. The number of seats available in all hostels under the University is limited. Owing to infrastructural constraints and a growing number of applications for hostel accommodation, it may not be possible to allocate rooms to every applicant. Applicants are therefore advised to take note of the limited availability and plan accordingly. Priority for hostel accommodation will be given based on predefined criteria, such as distance from the campus, academic performance, or as per the university's policies. Further details regarding the application process, eligibility criteria, and deadlines will be communicated separately. Additionally, candidates are informed that the hostel fee shall be payable only after the formal allotment of hostel accommodation by the competent authority. Students are encouraged to explore alternative accommodation options in case hostel seats are not allotted.
 13. In all matters of admission, including disputes and unforeseen circumstances, the decision of the University shall be final and binding. Any form of canvassing or malpractice shall result in disqualification and cancellation of candidature.
 14. The refund of fees, where applicable, shall be governed by the UGC Guidelines in force at the time of withdrawal/cancellation.
 15. In the event of any ambiguity or contradiction between the above instructions and the provisions stipulated in the Prospectus 2025–2026, the statements and regulations contained in the Prospectus shall prevail and be deemed final for all purposes.
 16. All legal disputes pertaining to the admission process shall fall under the jurisdiction of courts located in Koraput, Odisha only.
